

## PRIORITY ILLEGAL CONTENT AND RELATED CPS GUIDANCE

The Online Safety Act's illegal content duties apply to offences, defined as "priority illegal content" that are contained in <u>Schedule 5 (terrorism offences)</u>, <u>Schedule 6 (child sexual abuse offences)</u> and <u>Schedule 7 (a range of other offences)</u>.
